

Wake up now or Perish: Humanity in the hands of an unscientific medicine and fraudulent health industry

A brief history of COVID-19

This article is meant for every human being living on earth. We all know that all of us are besieged by the corona virus, COVID-19, and are aware of the social, economical, political and health consequences of the deadly infection. Even though we have failed to clearly delineate where it originated, Wuhan lab or Wuhan meat market. As a responsible nation, China failed to contain the virus locally in the city of Wuhan. A responsible and open Chinese system would have prevented its spread at its nascent stage itself. Kerala, a State in democratic India has successfully contained and eliminated the Nipah virus outbreak in 2018, which was deadlier than COVID-19. During the outbreak of Nipah, 19 people got infected, of which 17 people died. But the disease was contained completely within a period of 45 days from 2nd May 2018. Everything was done in public view with total support and awareness of the local population. Had the state of Kerala failed in publicly acknowledging the seriousness of the Nipah virus infection, it would have easily spread around the world as it is now the case of

COVID-19.

This contrast of approach of the democratic administration of Kerala and the totalitarian state of China is a glaring example of how the administrative philosophy and principles of a nation or state can influence the whole human population. This should be a learning curve for humanity to realize the long term dangers of totalitarian regimen, for their own people as well as the whole of humanity.

These events are mentioned as a preamble only to explain the story unfolding once the infection left China and spread all around the world. Initially in January WHO got notified about the infection and the Director General of WHO visited China and publicly acknowledged the Chinese effort to contain the disease. He also declared publicly that this is a Zoonotic infection (originating from animals) and will not spread human to human. But as the days and weeks passed WHO changed their position on the spread of virus and treatment of the infection frequently, making mockery of the world organization. Eventually all realized that the organization maintained for human health promotion on tax payers money around the world

was just a shady organization without any clear vision of global human health.

Why criticism on Arsenicum Alb is false and a lie

WHO eventually declared COVID-19 outbreak as a pandemic on 11th March 2020. The saddest thing about WHO is that the world body for protecting and promoting human health declared that there is no known cure or prevention for COVID-19. This declaration was immature, unethical and unscientific as WHO did not bother to look into any other possibility outside the conventional mode i.e. the so called modern medicine. At least in India there is a vibrant indigenous medicine and Homeopathy under the ministry of AYUSH (Ayurveda, Yoga, Unani, Siddha and Homeopathy) with a minister for the union of India and a separate AYUSH department in all its 28 states and 8 union territories.

In April 2020, AYUSH ministry of Govt. of India notified the immune boosting measures under AYUSH systems of medicine. It has mentioned specific modalities and drugs under each system of

AYUSH and requested the whole population in India to use them. The Govt. of India advised all states and union territories to distribute them for all citizens. As the Govt. of India and the state governments began the process of distributing these medicines, the hell-broke and there was loud hue and cry in all television channels and newspapers denouncing this approach as unscientific! The shrill and cry was particularly loud and violent against the homeopathic immune booster Arsenic alb 30C.

Indian Medical Association (IMA) representatives beelined into the TV channels during evening prime time talks and debates and orchestrated concerted attack on all AYUSH particularly They homeopathy. systems, consistently argued that these preventive measures of AYUSH are not part of COVID-19 protocols notified by WHO, hence invalid, with an additional jibe that all AYUSH medical systems are unscientific.

It is pertinent to ask two questions here. 1. Are there any valid preventive or curative measures in the so-called modern medicine for COVID-19? The answer is an affirmative No. 2. Is Arsenic alb a newly proposed homeopathic drug which must go through clinical trials? The answer is a definite No. Why? Arsenicum album, Arsenic trioxide (As2O3) was prepared by Dr Samuel Hahnemann 200 years ago. He did the clinical trials in his own body and 89 volunteers in his group. He found that 1065 signs and symptoms were produced in the healthy human mind and body by Arsenic alb 30C. Later 137 other volunteers also proved this drug and added further data into it. Totally 226 healthy volunteers took this drug and carefully recorded the signs and symptoms produced by Arsenic alb 30C in human mind and body. (Ref. Materiamedicapura; S. Hahnemann). This is the basis of homeopathic drug Arsenic alb suggested by CCRH (Central Council for Research in Homeopathy) under AYUSH ministry, Govt. of India. This drug along with hundreds of other drugs included in the official pharmacopoeia of Germany (1871), USA (1897), India (1971), UK, as well in French and European pharmacopoeia. Arsenic alb in different potencies is used around the world in millions and millions of patients for the last 200 years. This drug marvelously cured acute and chronic patients including numerous epidemics and viral infections. There are a number of research papers published in

peer reviewed journals regarding the action of ArsAlb in various clinical conditions including Arsenic poisoning. A simple Google search will bring these papers to your finger tip.

It is an unpardonable scientific fraud and a crime against humanity that out of sheer ignorance and arrogance the self declared guardians of conventional allopathic medicine is consistently trying to propagate misinformation in society by repeating the lie that Arsenic alb is not a proven drug. Whatever is the motive of the propaganda, it is a disservice to humanity as the human race is confronting deadly corona virus without any other known medicine than Arsenic alb.

In the initial few months of corona pandemic, political leaders around the world happily enjoyed the free publicity they were getting through the media day by day. Most of

them in fact all of them, tried to evade any sort of controversies and agreed to follow the protocols of WHO, central administrations and palace scientists, as political leaders are not scientists or doctors.

know the technocrats of health we scientific advisor's of departments or health systems around the world are conventional doctors or people close to the Pharma industry, starting from WHO to FDA or CDC to every state WHO has been perpetually governments. dominated by the major donor countries and organizations that contribute funds. As the USA relieved themselves from the controlling role of WHO, China took over the reins. Interesting fact is that the second biggest donor to WHO is the 'philanthropist' – Bill Gates.

From the beginning of COVID-19 pandemic itself the approach to contain the disease was a top-down approach. It completely ignored the regional health practices and expertise. As we scan through the health care practices around the world, India is the only country having a robust health care system with total freedom for the population to choose from systems of medicine they believe best for themselves. India is known for its

multicultural, multi linguistic and multi religious mode of existence.

Always in history healthcare was never a commercial enterprise in Indian civilization starting from Buddha's period, 500BC. Sadly that culture started changing for the last 70 years since the inception of WHO for the promotion and commercialization of health around the world.

It is very sad to note that all local and traditional health practices were dubbed as archaic and unscientific without any attempt to examine them objectively. It was a clever manipulation of the pharma industry which tasted immense money during the Second World War with the massive sales of penicillin. World War II helped to create the basic infrastructure for industrialized medicine, which they conveniently named modern the medicine to create an impression in collective consciousness that other approaches are outdated and archaic. During this process everyone conveniently forgot that the Homo sapiens remained physically and mentally same evolutionary modifications) for thousands of years. So the medicines acted on them all along are equally valid today or even for future generations.

India Fortunately abandoned its never traditional health care practices, which helped the population for millennia. But around the world most of the nations lost their indigenous healthcare practices during the last 70 years. Even though there were many pressure groups like IMA and rationalists, which perpetually worked together to kill the indigenous systems and Homeopathy in India, the political leaderships at national level and state levels are intelligent enough to see through the schemes of such organizations and assiduously supported every available health sciences.

At present India have around 750,000 medical practitioners outside conventional medicine (around 120,000 allopathic doctors). In recent years there is a reduction in the sales of allopathic drugs all over India. Some surveys noted that the pharma Industry suffered around 20% reduction in the sales volume, which amounts to billions of dollars worth. Pharma industry instituted surveys brought out the fact that this drastic reduction in sales is due to the extensive use of homeopathic medications by the patients. Pharma industry sees that this trend is not good for the profit oriented medicine sales, though it is very good for the suffering humanity.

There are many reasons for the general population to adopt homeopathy for acute and 1. Homeopathic doctors chronic illness. available in every village and city as primary care physicians. 2. Homeopathic medical graduates (BHMS) are equally educated and competent to the level of general medical graduates (both study 5 1/2 years with similar syllabus from anatomy to clinical medicine with different pharmacology). 3. The cost involved is negligible compared to the visit to a hospital. 4. Treatment is generally very effective to cure many chronic illnesses never cured in conventional medicine. 5. There are no known side effects for homeopathic drugs. 6. Holistic approach is more acceptable to the people as they gain more knowledge on health an issue directly as knowledge society is evolving. In the earlier world, medical knowledge was the privilege of doctors and patients were illiterate in medical science.

We do not have any interest in conspiracy theories or similar approaches analyzing a situation like this. This is a simple situation where multinational pharma business empires realize that their profits are dwindling continuously. They found this trend slowly gaining ground and spreading to other geographical areas too. Scientific data analysis tells them that the primary reason for this business loss is due to the influence of AYUSH in general and the broadening practice of homeopathy in particular.

General population has a divine feeling about the healthcare industry. Idealising that the pharma industry is researching and discovering drugs to cure the illness. But any capitalist industry looking for profit will never be divine but rather merchants of death when they deal with profit versus loss issues. Please do not think that boardrooms of these industries are discussing each patient's well being. It is obvious that they only discuss numbers and profits.

Question now for the conventional medicine industry is, how to reverse this trend of people slowly shifting towards AYUSH in general and Homeopathy in particular. Answer is simple 1. Stick on to the tag of modern medicine and use the word science every moment to add additional credibility 2. Constantly accusing AYUSH is fraud, unscientific and obsolete. The basics of this strategy were evolved in the last few years

simultaneously with the formation of the AYUSH ministry in India.

Kerala is a typical playground for this experiment as Ayurveda and Homeopathy are in footing with conventional equal medicine. Cracking the backbone and public support for Ayurveda and Homeopathy in Kerala is the real intention of the global pharma industry. Mystery of Modern Medicine: Rockefeller to Bill Gates

This is a pattern experimented and successfully implemented in the USA and Canada with the submission of Abraham Flexener report 1910. Within two decades the capitalists and their cronies succeeded in denying the American people the service of other systems of medicine than allopathy. (Abraham Flexener commission was founded by Rockefeller foundation and Carnegie foundation) If they succeed at this nefarious design of maligning and overthrowing AYUSH systems from Kerala, that will mark the fall of the last point of resistance against the monstrous medical industry. The people of Kerala will loose the freedom of choice in healthcare forever and will become slaves of allopathic capitalist health model as in UK or USA; which will keep them always in health slavery without any cure whatsoever. Just see that thousands of cancer patients receive best palliative care in India through AYUSH systems, But in the UK it is legally forbidden for cancer patients to choose

anything other than radiation therapy and chemotherapy. In simple terms this is nothing but medical terrorism.

Abraham Flexener was a science administrator and politician. In 1905 Carnegie foundation (Andrew Carnegie) and John D Rockefeller together funded Flexener and instituted the commission to report on medical education in the USA and Canada. Flexener's report created the basis of today's conventional bimolecular modern medicine. With the support of the report, in 20 years (1910 - 1930)the capitalists created the bimolecular medicine that succeeded to eliminate other medical systems including homeopathy from the government funding thereby killing the academic institutions, eventually the downfall of the pluralistic approach in health care.

Similar is the evolving situation in India too. As the profits dwindle, capitalists acquire competitors (like we have only one company making shaving blades — Gillette, One major company manufacturing toothpaste — All done by P&G) or try to kill them. In the industrial field, acquisition and assimilation is possible but in human health this is not viable as each system of medicine is rooted on different philosophies. Conventional medicine tries

to impress the people that it is a pure science not having any philosophy. But it is rooted on Cartesian dualism (mind and body parallelism), Newtonian objectivity and predictability and the capitalist funded political report of mediocre intelligent man 'Abraham Flexener'.

In 1905 Andrew Carnegie and John Rockefeller were the 'philanthropists'. Now Bill Gates and Melinda Gates with Gates foundation took over the baton to carry over the capitalist agenda of making illegitimate profit out of the human body and mind. Carnegie and Rockefeller created a report in medical education to streamline the medical world to sell their industry products as medicines. They succeeded and created the biggest capitalist enterprise in human history i.e. conventional chemical intensive biomolecular medicine.

With the discovery of DNA by Watson and Crick in 1953 the scientific foundation of biomolecular medicine based on Virchow's cellular pathology (1868), microbiology and antibiotics (Alexander Fleming 1928) became logically irrelevant and scientifically unsustainable. It was a failed model all along except in accidents and emergencies to save life. The harm done by the conventional drugs after

RCTs (randomized control trials) and so called rigorous scientific validations are innumerable, to quote a few examples.

1955- 1961: Use of thalidomide in pregnant women for morning sickness in 46 countries with more than 10,000 children born with severe deformities (phocomelia – malformation of arms and legs) and thousands of miscarriages.

Atorvastatin- lipid lowering drugs — found ineffective in preventing heart attack after unfettered use for 25 years (with 1.6 trillion USD sales) could also produce liver failure, kidney failure and serious adverse effects to the developing foetus — still in use all over the world.

In 2018, 178 drugs were withdrawn by the USA FDA with some being noted as dangerous drugs.

Recently 344 drugs were banned in India by the ministry of health.

From these data it is very clear that the scientific methodology of drug discovery in biomolecular medicine is imperfect and defective.

As the conventional medicine created by the early capitalists started showing the signs of dangerous side effects and proved ineffective in curing any chronic disease, the new generation

capitalists under the leadership of Bill Gates started looking for a new business model and they sensed the gold in a new health enterprise i.e. universal vaccination. Anything universal in the healthcare industry has a potential of 7.50 billion clients. A fantastic business model! But 7.50 billion people do not share common genetic code; each individual has their own unique genetic code. This is the point in which the misnomer 'modern medicine' is being questioned.

In 2019; 251, 454 – 800,000 people died due to iatrogenic (treatment induced) causes in the USA which is nearly 10 -36 % of total deaths in a year. Till now the total number of deaths due to COVID-19 in the USA is around 200,000. This statistics is highly informative and equally valid for nations around the world.

There is a well orchestrated and organized effort from the top end of pharma and vaccine industry to completely destroy AYUSH systems in India. They are implementing this dirty agenda utilizing the service of health administrators under the fire power of IMA, bypassing the wish of people and will of political leadership. Vigilance of people is the only way to prevent this fraud. People of Kerala who immensely benefited from the service of AYUSH

Part IV

Evolution of Medical Science: Homeopathy- The Post-modern Remedy

From the beginnings of civilisation, there have been healers to cure illnesses.

Sumerians and Egyptians had their health care practices, that were modern medicine for them. Egyptians trained the doctors at the temple of Imhotep. Indus valley and Mycenaeans had their health systems. Later Greeks and Indians had built up robust ways to treat diseases. In the ancient universities of Nalanda and Taxila, medicine was taught intensively for years (Ayurveda). Later, Greek medicine slowly morphed into Roman medicine through Galen (1st century AD)

All these systems of medicine, though varied, have a holistic approach as the essence. Health was synchronized with the unity of mind and body. The practice of Ayurveda was well oriented towards holism, except in its surgical procedures. All these ancient medicines were modern at the period, like the conventional modern medicine of today.

Definitely people died all along due to natural diseases, but at no point of time too many people died of iatrogenic diseases, as it happens today. At no point in history so many people died of side effects of drugs as today. At no point in history too many people became sick and died (renal failure, liver failure, cancer etc.) due to the side effects of drugs as today.

All these started with the advancement of medical science under Cartesian duality (mind - body Newtonian objectivity parallelism) and the predictability purpose. Conventional as medicine always claims that it is evidence based without understanding where the concept of 'evidence based' had its origins. Indeed it originated from Physics. Cartesian dualism is valid in the process of inquiries of the physical world. In the inquiries about the nature of the physical world (science) it is imperative to keep the subjectivity of the observer unprejudiced in observation and (Lord Bacon). Later Paracelsus conclusion contributed much by integrating the analysis of body fluids (blood, sputum, urine and stool) for clinical diagnosis.

The theories of Descartes, Newton and Bacon propelled the speed of scientific advancement in Europe in the 17th, 18th and 19th centuries. But medical science was lagging behind as it is much more complex than the mechanical non living world. The difficult question of the modern world was how to holistically integrate the phenomenon of the mind-body complex in health and in disease. With the 'capitalist dictated' report of Abraham Flexener in 1910, the modern world decided to study the tissues, organs and systems of the human body as true realities of existence conveniently side lining or rather ignoring the mind. We must understand that today's conventional modern medicine owes its fatherhood to a mediocre health administrator and unsuccessful politician who were employed by capitalists with an agenda. Mediocre intelligence never created any scientific philosophical system long lasting in human history.

Leaving holism (integral being) in lurch, conventional medicine advanced fast to reach heights. This system attracted the best and brilliant minds in biology in the last one century owing to its appeal in social upliftment, economic benefits and a false prestige of superiority attached to this

system. Barring a few, the majority of conventional physicians never realized that all the chemical formulas used in health care from acetaminophen antibiotics, (Paracetamol), steroids. to chemotherapeutic systematically agents are depriving the human immune system built over a million year. Many well intentioned conventional doctors feel this pain and they try to integrate their learning with homeopathy or other holistic systems successfully cure patients. Many others and completely switch over to homeopathy. There are thousands of conventional modern doctors practicing homeopathy around the world, qualified in homeopathy, in addition to their degree in conventional modern medicine.

It is very sad to note that the brilliant doctors of conventional medicine were perpetually exploited by the chemical intensive pharma industry to promote sales and marketing of their products time and again. Doctors who sensed the unethical ways of the pharma industry and dangers posed to the human immune system by these approaches and dared to question them were threatened using bodies like IMA and silenced eventually by hook or crook. Majority of conventional physicians live

on with their profession, treating patients but never single chronic patient curing a (Diabetes, hypertension, psoriasis, hypothyroidism, Addison's disease, migraine, allergic disorders, autoimmune disorders, cancers etc.). But the powerful pharma industry and professional associations reinforce their medical school learning that they are the only true scientific medicine and all other systems of medicine are outdated and unscientific. It is like the who falsely claim that religions spiritual enlightenment is only through their sect. Today's modern medicine is trying to inculcate a cult order rather than open ended inquiry misusing the word 'science'. As sufficient job opportunities and social respect is sustained, doctors generally do not bother much about the world beyond their narrow precincts of existence. I have seen many of my friends in conventional medicine get perplexed and confused when they see the patients, whom they could never cure, get completely cured with homeopathy, Ayurveda, other AYUSH systems or any other science of medicine. But we should remember that all these intelligent conventional doctors are also ordinary citizens at one end, who spent the best part of their life learning, learning learning. Denying years of effort and

re-learning is very difficult and many times impossible. It seems all are in an enclosure difficult to peep over.

Why did the effort of thousands of brilliant minds fail to achieve curative results in conventional modern medicine?

Every medical student entering into a medical school at the end of teenage is not a philosopher or scientist or a mature mind. She/ He is only a student taught as per the syllabus and curriculum of the medical school. They are learning and writing exams perpetually for years even without having time for any entertainment. This perpetual learning skilled workers of modern moulds them as medicine without critical thinking and alternative thoughts. The Abraham Flexener report (1910) recommended the syllabi and curriculum of Johns Hopkins as the best model, which never had any provision for critical thinking and learning of history of medicine as an integral part of human civilization. Its self proclaimed aura of superiority based on learning starts with Anatomy and Physiology, ending in clinical Medicine slowly spread around the world as a standard model. Even

during my graduation in homeopathic medical college, I had gone through the same model.

Everything was exciting and optimistic in conventional modern medicine till the discovery of DNA in 1953. This discovery opened up a totally new area of subtlety hitherto unknown to the world of medicine. There was no possibility to integrate the then used medicines into this new discovery, so the medical industry conveniently ignored them for half a century, till 2000. After the genetic decoding in 2000, the science of genetics, epigenetics and immunogenetics started redefining the horizons of medicine. The science in knowledge conventional modern medicine and its industry found incapable to do anything at this situation. The cause of diseases shifted from the gross cellular and biochemical level to the nano scale of genetics. The basic rule of the game is changed! Old ways and means will never work anymore.

This situation created an existential crisis for the monstrous and complex industry of conventional medicine. Doctors treating patients at hospitals or clinics daily are mostly not aware of this existential crisis of so-called modern medicine. It is like the employees in the Kodak film industry in 2001. They could never imagine the 113 year old company with a film based camera and the powerful industry would close down within a couple of years and make them jobless.

Part V

Homeopathy: The Post Modern Personalized Nanomedicine

Homeopathy is the best suited option for the makeover of medicine from biomolecular chemical intensive therapy to nano pharmacology and genetic medicine. Proponents of conventional modern medicine boast everyday that scientific research and RCT (randomized control trials) are the cornerstone of drug development. It is important to know the scientific methods prior to different levels of RCTs. Drug experiments on the animals are starting point lower fundamental basis of data collection. Why is it done so? Because all these drugs are toxic, hence dangerous to life. So the primary animal studies and later stage I, II and III clinical trials.

What are the logical errors in this system?

- 1. Human system is an integrated mind and body unity, in which the human mind is evolved into rational and conscious levels. In lower animals this integrity is lacking and their mind is evolved only up to instinct level.
- 2. Human immune genetic system is much more advanced, complex and incomparable to lower animals.
- 3. Homeostasis in human beings and lower animals are totally different.
- 4. The statistical averages derived from the studies of lower animals and clinical trials are only averages. As the genetic system of each individual is unique, average values are only an approximation of reality, never the truth.

Conventional systems of medicine always claim that new drugs are to be discovered for every new infection. For example COVID-19 is caused by a new virus so needs to be treated with a new drug. Protagonists of this approach criticized when homeopaths opined that the existing medicines in homeopathy (eg. Ars Alb) can be used for

prevention and cure of COVID-19. Let us examine this 'new drug for new infection' argument. This argument suits for the standard patterns of conventional medicine.

In homeopathy the approach to drug discovery is different. How is the drug discovery done in homeopathy? Homeopathy has a unique method of 'drug proving' to study the drug. This can be compared to the stage III or IV clinical trial in conventional medicine. Homeopathic drugs in 30C $(1/10^{60})$ preparation are given to healthy volunteers, 4 pills 4 times daily for 3 days initially and repeat the same every 30 days up to 12 months. The train of signs and symptoms evolving are carefully analyzed and recorded. These presentations are the basis of homeopathic drug discovery. Similarity of clinical presentation patient's with the presentations of the particular drug is the basis of remedy selection for a patient in illness, in accordance with the fundamental principle homeopathy – Similia Similibus Curentur. This is not at all an approach of statistical averages based on biochemical parameters as in conventional medicine.

approach is Homeopathic completely individualistic in contrast to the statistical mode of conventional medicine. There are many recent studies in genetics reported in peer reviewed journals with homeopathic 30C drug solutions establishing that theses drug solutions in 30C produce epigenetic modifications like up regulation, down regulation, switching on and switching off of the genes. Similarly recent research works with modern electron microscopy, spectroscopy and other techniques shows homeopathic drugs in all potencies at all higher dilutions contain plenty of nano particles of original drug substance (Reported in many peer reviewed journals).

These recent discoveries open up a new vista of possibilities, which 'define homeopathy as a post modern curative therapeutic approach' in disease conditions, far advanced than today's conventional modern medicine. It is logically clear that the 30C used in drug proving experiments give rise to transient epigenetic modifications to bring forth signs and symptoms in the human mind and body. Later when the same drug is given for patients suffering from similar signs and symptoms curing the disease means the reversal of epigenetic

modifications that initiated the disease. Now, we understand how homeopathy cured millions of patients around the world without ambiguity. But nothing prevents researchers to follow the path of further research to understand deeply the finer mechanisms leading to the cure in each disease with homeopathic personalized nanomedicine.

Pure science is always truth seeking and unprejudiced. But, if the science is tied up with the commercial capitalist pharma industry it is liable to get corrupted. Such corruption is what is glaringly seen in the field of conventional modern medicine. The therapeutic medicine researchers and policy makers around the world should rethink and abandon the current strategy of conventional medicine. Changing the philosophy of medicine from Cartesian dualism to holistic approach integrating nanotechnology and genetics is the need of the hour. Which obviously leads to holism in medicine and personalized medication for each patient, rather than common therapy based on statistical averages and diagnostic terms. If policy makers and political leadership catch up with this wholesome idea of human health, I am sure that just in one or two decades human health will be

redefined for the betterment of human life, the economy and for sustainable development.

The current approach of research based on the commercial needs of the pharma industry is killing all possible intellectual pursuits in the medical research. Every medical researcher has been forced to abandon ideas which question the current paradigm of linear reductionist thoughts of conventional medicine. Instead of using drugs with dangerous side effects, all natural diseases could be treated in the first line by homeopathy and other natural methods, not only in India but all over the world. Whenever a need arises, only then, should the conventional drugs be used as an alternative therapy. In fact conventional modern medicine therapy should be re-designated as 'alternative medicine' except in life threatening emergency situations and unavoidable surgical conditions.

The Government of India recently decided to introduce AYUSH systems in the syllabi of conventional medicine. It is a welcome step, but at the same time, the government should insist on opening inpatient and outpatient units in every medical school with experts of each AYUSH system. First hand learning to be imparted to the

conventional allopathic doctors about other health systems to understand the significance and value of AYUSH systems in health care.

All policy makers around the world should take immediate initiatives and decisions to introduce training in homeopathy to all modern medicine specialists. It should be insisted that any surgical and other procedures, except in life threatening conditions, need to use at least two alternative modes of therapies before deciding on surgery, transplantation, etc. This suggestion comes from hundreds of recorded experiences with patients who were waiting for surgery but cured with homeopathy. Patients and homeopathic physicians around the world have millions of such experiences. Instead of conducting studies on such cures, blindly denying the truth of such recoveries as placebo effect is self defeating and against the progress of humanity.

This multi system approach in patients before resorting to costly procedures will drastically reduce the skyrocketing health expenses in the world, which even the economically advanced nations, find unable to afford. Universal health insurance is really a cover up to hide this looting of

the industry. The current attitude in this system is 'as you don't pay you don't bother' the cost. But in reality all are paying exorbitant as we pay taxes. Always industry is the beneficiary. Best example for this reality is the standard conventional treatment for cancers.

Therefore, integrating different systems of medicine in patient care and making sure that every general practitioner and specialists are aware of different possibilities of treatment needs to be implemented all over the world as soon as possible to upgrade the art & science of healing. This will help younger minds in medicine to experience the need of diversity in health care and medical science. It is the time for every doctor in the world to reinvent their real self, which is not slavery to the industry and medical associations but the call to alleviate the pain of suffering human beings with all available source of knowledge.

Part VI

Why Different Systems of Medicine?

Conventional modern medicine claims it is more scientific than other systems of medicine.

This claim is based on a few scientific dicta arising from statistical averages and the structural framework of clinical trials.

These statistical averages are relevant and valid in the research of conventional drugs because they ignore the subjectivity in drug research. Similarly the structural framework of double blind and triple blind clinical trials are also leading to statistical averages to come to conclusions. These approaches are efficient only up to the point wherever averages in the measured physiological and biochemical parameters in the human body are relevant. They are defective and insufficient as research tools for homeopathy as homeopathic drug discovery research goes beyond the basics of biomolecular level of genetics medicine to the immuno-genetic modulations. The physiological at the level of genetics processes and

immunogenetics are individualistic, not common for all. Moreover at this level the influence of subjectivity is remarkable. This is the reason for success of homeopathic medication in millions of patients around the world who were declared incurable by conventional medicine.

We have discussed many examples starting from thalidomide induced genetic defects and list of drugs banned year after year to demonstrate the fallacies of the conventional approach of drug discovery. All drugs from thalidomide to the most recently banned drugs have gone through these so called rigorous animal experiments and many levels of clinical trials like double blind and triple blind studies. Then, why do all these drugs produce like disastrous consequences such genetic anomalies and serious other side effects when clinically used in patients? We need only simple sense to understand that the drug discovery system in conventional modern medicine is unscientific or that the science on which it is based is incomplete and not the final word and thus the product created is defective and harmful to human beings. Fundamental rule in any medication is that the drugs prescribed should not produce

more pain and suffering than the original disease. But here it is indeed so.

If we analyze these so-called scientific methodologies with the current level of knowledge in genetics, they are archaic. Yet the pharma industry and their apostles projects them as the most advanced and scientific methodologies out of ignorance or for simple profit motives. How long will they be allowed to continue this fraud on human health? Policy makers around the world should understand this point and there should be a effort the Flexener's concerted to re-write commandments by a real humanistic scientist.

The first clinical trials in modern times started with the trial of 'patulin' for the common cold in 1943 in the UK. It was the first double blind controlled trial. Then came the first randomized controlled trial of streptomycin in pulmonary tuberculosis, again in the UK in 1946. Everyone should note that these ultimate research tools (various stages of clinical trials) as the basis of conventional drug discovery are pre-DNA discovery period protocols. Even today research methodology of drug discovery does not consider the genetic uniqueness of each human being to

whom it is prescribed. This is a very serious defect that is not given cognizance in the pharmaceutical industry. Keeping an outdated protocol which does not take into account the basic genetic system of human beings, is the biggest fraud and greatest crime against humanity. The attempt to universally inject COVID -19 vaccines based on mRNA needs to be understood in this context. It is not only an attempt to deny the basic freedom and personal choice of individuals but can damage the genetic code of human beings irreparably. It is high time for the political leaders to use their human instincts as well as intellect and broad knowledge rather than depending on the so called experts who are prejudiced and closely linked to the industry. Political leaders should understand that their decisions are linked to the larger questions of existence.

Homeopathy is a medical system discovering drugs exclusively by studying their effect directly on healthy human subjects (drug proving experiments) by using 30C potency of a given drug or substance. This makes the methodology of homeopathic drug discovery fool proof and pristine. We also note that the drugs discovered by Dr

Hahnemann (99 drugs) to the drugs recently included in the homeopathic pharmacopoeia, are all in daily use in homeopathy. But as a researcher who did one decade of studies with homeopathic ultra-high dilutions with advanced electron microscopy (HRTEM & EDS, FESEM & EDS) and Dynamic Light Scattering (DLS), I am confident that these high dilution medicines are the rich source of nanoparticles of original drug substance (See ref. book the Nanodynamics and other published research papers in peer reviewed journals). I am also sure that millions of patients cured of their illnesses with this personalized Nanomedicine (Homeopathy) are the living examples of a worthy science to heal human diseases.

The proponents of one medical system for the world should realize that the so called modern medicine they are trying to implement in human society is an outdated science utilized to the maximum as a business enterprise, has little or no

But the home grown medical industry is killing the immune system of every American by unscientific drugging and directly killing more than 250,000 Americans through adverse medical reactions and other
